



VT MARKETS “TRADE TO LUXURY 2026” TERMS AND CONDITIONS (MY)

The VT Markets “Trade to Luxury 2026” (hereinafter referred to as the “Promotion”) is provided by VT Markets LLC (hereinafter referred to as the “Company” or “VT Markets”). This Promotion is exclusively offered to eligible clients of VT Markets who meet the eligibility and participation requirements as set out herein.

TERMS AND CONDITIONS

A. Eligibility

1. This Promotion is valid from **20 May 2026 to 31 December 2026** (the “Promotion Period”).
2. This Promotion is open to **new and existing clients** of VT Markets who:
 - Open a **new live trading account** (MT4 or MT5) during the Promotion Period; and
 - Successfully opt in to the Promotion via the **Client Portal**; and
 - Reside in the following eligible country/region:
MALAYSIA
3. This Promotion is applicable to the following account types: **STP, VIP, ECN, Cent, Swap-free, and Copy Trade** accounts. **MAM and PAMM accounts are strictly excluded.**
4. Each client is permitted to participate using **one (1) User ID only**, and each User ID is eligible for **one (1) prize redemption only** throughout the Promotion Period.
5. This Promotion **cannot be combined** with any other VT Markets promotion, campaign, or incentive.
6. VT Markets reserves the right to amend, vary, suspend, or terminate this Promotion at any time without prior notice.

B. Participation & Qualification Criteria

1. To participate, eligible clients must:
 - Open a new live trading account; and
 - Opt in to the Promotion via the VT Markets Client Portal during the Promotion Period.
2. Qualification for rewards is strictly **performance-based** and subject to:
 - **Cumulative gross deposit amount**; and
 - **Cumulative trading volume** (in lots), both of which must be achieved **after successful opt-in**.

3. Only **closed trades** executed on the following instruments shall be counted toward trading volume:
 - FX
 - Metals (XPDAUD)
 - Gold (XAUUSD, XAUAUD)
 - Silver (XAGUSD, XAGAUD)
 - Crude Oil (CLOIL, USOUSD, UKOUSD)
 - Bitcoin (BTCUSD)
4. Only trades held for **more than three (3) minutes** shall be counted.
5. **Internal transfers** between trading accounts or rebate accounts shall **not** be considered valid deposits for qualification purposes.
6. Accumulated deposits and trading volume shall be calculated **per User ID**, aggregated across all eligible trading accounts under that User ID.

C. Rewards & Redemption

1. Clients may apply to redeem any listed reward **once the corresponding deposit and trading volume thresholds are fully met** within the Promotion Period.

 - All reward redemption requests must be **successfully submitted no later than the 15th calendar day of each month** (the “**Monthly Cut-Off Date**”) for consideration within that respective month.
 - Redemption requests submitted **after the Monthly Cut-Off Date** shall be deemed as submissions for the **following calendar month**, subject to the availability of rewards and the applicable **monthly reward cap** as stated in the Reward Table.
 - All approved rewards shall be fulfilled within **thirty (30) to forty-five (45) working days** from the date the redemption request is **fully verified and approved** by VT Markets.
 - **15 January 2027** shall be the **final deadline** for prize redemption claims. Any redemption request submitted after this date shall be deemed invalid, and the client shall automatically waive all rights to the reward.
 - VT Markets shall not be held liable for any delay in reward fulfillment beyond the stated timeline where such delay arises from circumstances beyond its reasonable control.

1. All participating accounts and trading activity shall be subject to monitoring during and after the Promotion Period.
2. VT Markets reserves the right to disqualify any client found to have engaged in **abusive, manipulative, deceptive, or fraudulent activities**, including but not limited to:
 - Artificial volume inflation
 - Internal or external hedging
 - Multiple or linked account abuse
 - Exploitation of system loopholes



3. Rewards issued shall remain subject to a **post-settlement review period**, during which VT Markets may revoke, recover, or nullify rewards in the event of policy breaches or compliance concerns.
4. VT Markets may withhold, deduct, or offset rewards due to AML investigations, compliance adjustments, chargebacks, or account reconciliation corrections.

E. General Disclaimers

1. Prizes are subject to availability. VT Markets makes no guarantees regarding prize fulfillment timelines.
2. VT Markets shall not be responsible for delivery delays, administrative disputes, or any indirect, incidental, or consequential losses arising from participation in this Promotion.
3. Clients participating in this Promotion are **not permitted** to opt in to any other **Trade & Win** or similar campaigns offered by VT Markets or its affiliates during the same period.
